ORDER

Cancellation of Candidature for the post of Assistant Teacher (Primary)-42/21

Whereas, Ms. Shivani Gaur (Roll no. 111604205769, D.O.B 27.02.1992) was provisionally nominated by the DSSSB for the post of Assistant Teacher (Primary) under post code-42/21 and accordingly offer of appointment was issued to the candidate vide Office Memorandum No. DE.4(49)/DRC/E-IV/PRT(42/21)/2023/14 dated 08.01.2024 & subsequent reminder dated 04.03.2024 with the direction to appear for document verification held on 22.01.2024 & 11.03.2024 respectively.

And whereas, during the course of document verification, a deficiency memo was issued to the candidate vide letter dated 11.03.2024 regarding NCTE recognition certificate for the two years D.Ed. course for the session 2018-2022. Subsequent reminders I, II and III were also issued to the candidates vide letter dated 19.06.2024, 16.07.2024 and 24.07.2024 respectively.

And whereas, the candidate has passed D.Ed. course from Calorx University which is a private University and as per the Recruitment Rules for the concerned post the candidate should have passed Senior Secondary (or its equivalent) with at least 45% marks and 2-year Diploma in elementary education (by whatever name known) **in accordance with the NCTE (Recognition Norms and Procedure) regulations-2002.**

And whereas, the candidate has been issued last opportunity vide letter dated 11.03.2025 to submit the requisite document.

And whereas, the candidate had filed a Writ Petition (Civil) in the Hon'ble High Court of Delhi against NCTE & Ors. The Directorate of Education has also been made respondent No. 3.

And whereas, the Writ Petition (Civil) No. 10371/2024 titled as Shivani Gaur Vs. NCTE & Ors. has been disposed off by the Hon'ble High Court of Delhi vide order dated 05.09.2024.

In view of the above, the offer of appointment issued to Ms. Shivani Gaur (Roll no. 111604205769, D.O.B 27.02.1992) is hereby withdrawn and the candidature stands cancelled. No further correspondence, in this regard, will be entertained by this department, in future.
