ORDER

Sub: Withdrawal of Cancellation Order dated 04/03/2024 in respect of Mr. Ajay Deswal (DOB: 07-06-1996), Roll No. (121104200347), a nominated candidate of 'EWS' category for the post of Assistant Teacher (Primary) under post code 42/21.

Whereas, Mr. Ajay Deswal (DOB: 07-06-1996), Roll No. (121104200347), a candidate of EWS category was provisionally nominated to the post of Assistant Teacher (Primary) under post code 42/21 in 'Main Merit' of 'EWS' category by DSSSB vide Result Notice No. 1489 dated 02/11/2022 in pursuance of Vacancy Notice Advertisement No.02/21 dated 12.05.2021. Whereas, aforesaid candidate was not able to produce valid EWS Certificate issued before cutoff date, therefore, his candidature for the post of Assistant Teacher (Primary) was rejected vide Cancellation Order No. **F.DE.4(60)/DRC/E-IV/PART FILE/(42/21)/PRT/2023/Pt1210-14 dated 04/03/2024 .**

And Whereas, Mr. Ajay Deswal, aggrieved with the cancellation order dated 04/03/2024, filed an O.A. no 1226/2024 before Hon'ble CAT.

And whereas, the Hon'ble Delhi High Court has upheld the orders/directions passed in O.A No-1226/2024 and in other similar matters in r/o other post code(s), by the Hon'ble CAT in O.A. No. 1524/24 (in Anju & Ors. case) and 1551/2022 (in Rishikesh Sharma case), vide judgment dated 19.07.2025 in W..P.(C) 2814/2024 (filed by GNCTD & Ors. and clubbed with WPC Nos. 15889/23, 15912/23, 15953/23, 16440/23 & 16552/2023) by dismissing the filed writ petition(s) by Hon'ble High Court of Delhi. The Hon'ble Supreme Court of India has also upheld the order/judgement passed in WP (C) No. 2814/2024 vide judgment dated 04.09.2025 in SLA (C) No. 13026/2025 (filed by DSSSB & Anr.).

Whereas, the candidate was asked by the Department to attend the Office in person to submit all the documents and testimonials and specifically the original EWS certificates for the last 03 financial years i.e. 2019-20, 2020-21 and 2021-22 alongwith one set of duly self attested documents vide Memorandum number — F.No- DE.4(118)/DRC/E-IV/PRT(42/21)/CourtCases/27 dated 09/02/2026. All the requisite documents submitted by the candidate are accepted by the Department.

Now, therefore, in compliance of the directions of the Hon'ble CAT/ Courts as mentioned above and with the approval of the Competent Authority, the Cancellation Order No. **F.DE.4(60)/DRC/E-IV/PART FILE/(42/21)/PRT/2023/Pt-1210-14 dated 04/03/2024** in r/o Mr. Ajay Deswal, is hereby withdrawn with retrospective effect.
