Consequent upon nomination through the Delhi Subordinate Services Selection Board to the post of TGT SOCIAL SCIENCE (Female) vide letter No.F.1 (70)/DSSSB/P&P/09/2226 dated 16.10.2024 and in compliance of Hon'ble CAT order dated 24.07.2024 in O.A. No. 334/2019, the offer of appointment dated 04.06.2020 for Ms. Asha, was revived and restored vide Memorandum No. DE.3(98)/E-III/DR/2016/571 Dated 12.12.2024. Further, with prior approval of the Competent Authority, Ms. Asha, Roll No. 6011443, Category-SC is hereby appointed purely on a temporary and provisional basis, for the post of TGT SOCIAL SCIENCE (Female), vide Post Code-10/10, in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised), plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by her.
