Consequent upon nomination through Delhi Subordinate Services Selection Board for the post of TGT-Sanskrit (MALE) vide letter No. F.1 (155)/P&P/DSSSB/ 2012/2963-2966 dated 29.07.2025 & Result Notice No. 983 dated 10.07.2025 and in compliance of Ld. CAT order dated 09.07.2024 in O.A No. 1039/2019 titled as Rituraj Khandal Vs DSSSB & Ors, which was further upheld by the Hon'ble High Court of Delhi vide order dated 19.02.2025 in W.P(C) No. 2165/2025 & CM Appl. 10177/2025 & 10178/2025. Further, with the prior approval of the Competent Authority, the following candidate is hereby appointed purely on Temporary and provisional basis, under the relaxation of FR. 10(4) for the post of TGT- Sanskrit (Male) Vide post code 116/12 in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him. The provisional appointment and draw of pay and allowance for a period not exceeding 2 months is subject to medical examination within 2 months from the date of provisional appointment under provisions of FR 10 and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him/ her of the findings of the medical officer/board, if no appeal for second medical examination is finally decided if such an appeal is made and accepted. He would also be entitled to all consequential benefits on notional basis; however, on actual basis from the date he joins the post, at par his immediate junior appointed in merit list as per the Hon'ble Court directions, if any. The candidate is hereby directed to report to his respective place of posting latest by 14.11.2025 failing which his appointment shall stand cancelled without any further communications.
