	4.	Where the Administrator is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing relax any of the provisions of the rules with respect to a class or category of persons/posts.
	5.	The crucial date for determining the age limit mention in column 6 of the recruitment rules will in each case be the closing date for receipt of applications from candidates in India (Other than Andaman & Nicobar Island and Lakshadweep). In respect of posts, the appointments to which are made through the Employment Exchange, the crucial date for determining the age limit will, in each case, be the last date up to which the Employment Exchanges are asked to submit the names.
